 - Applicants must re-apply annually if they wish to be considered for this scholarship in subsequent years.
 - The scholarship amount may vary from year-to-year.
1. The applicant must be a high school graduate of a school within the Commonwealth of Pennsylvania and the child of a U.S. Veteran at the time of his or her selection to receive award.
 2. The applicant must provide the following:
 - a. A Completed Application Form.
 - b. An Official transcript of current grades.
 - c. A typed essay, not to exceed 500 words, that includes information about the student's educational and career aspirations, accomplishments and interests.
 - d. A minimum of two (2) letters of recommendation, on school letterhead, from members of the faculty and/or administration.
 - e. SAT or other college-bound test results.
 3. The Scholarship Committee will wholly consider the following criteria:
 - a. The character of the applicant (as determined from the applicant's essay and letters of recommendation).
 - b. The scholastic record of the applicant.
 - c. The achievements and goals of the applicant.
 - d. Other criteria as set forth in the terms of the document.
